
In terms of Government of India, Ministry of Personnel, Public Grievances and Pensions (Department of Personnel and Training) OM No.35034/1/97-Estt(D) dated 09.08.1999 and O.M. No.35034/3/2008-Estt.(D) dated 19.05.2009 read with Headquarters circulars no. 23-Staff Wing/2016 issued under letter no. 39-Staff(Entt.I)/184-2014 dated 20<sup>th</sup> June, 2016 and no. 38-Staff Wing/2016 issued under letter no. 62-Staff(Entt.I)/184-2014 dated 19.10.2016, the officers listed in Annexure –A and B have been granted financial up-gradation with effect from the dates noted against the name of each officer either under the Assured Career Progression Scheme or both under Assured Career Progression Scheme and Modified Assured Career Progression Scheme respectively, subject to the following conditions viz.:

- (1) There is no change in the Designation and Status of the officer on getting such financial up-gradation. The officer concerned will continue to be borne in the cadre in which they happen to belong on the date of effect of this order in respect of officers who are in service.
- (2) The component of financial enhancement allowed under ACP/ MACP Scheme shall not be taken into consideration for any further fixation in the event of their regular promotion in future to any post having the same/ higher level in the Pay Matrix, if the officers are in service.
- (3) The officers who have been granted financial up-gradation shall however be entitled to exercise option under FR 22(I)(a)(I) to get the admissible amount fixed either on the date of up-gradation or on the date of their regular increment; They are requested to exercise their option in the prescribed format obtainable from Administration-III Section within one month from the date of issue of this order.
- (4) No stepping up of pay in the higher cell/ level of the Pay Matrix shall be admissible with regard to any junior getting more pay than the senior on account of pay fixation under the ACP/ MACP Scheme. Financial up-gradation under the ACPS/ MACPS shall be purely personal to the employee and shall have no relevance to their seniority position As such, there shall be no additional financial up-gradation for the senior employees on the ground that the junior employee in the grade has got higher pay in the level of the Pay Matrix under the respective ACPS/ MACPS;
- (5) The notional benefit of financial upgradation(s) under ACP/MACP Scheme to serving and retired persons would be admissible from the date on which the official became eligible for the same. However, the actual monetary benefit of pay and allowances/ pension shall be admissible from the date of issue of the Headquarters' circular no. 23-




