Subject: Extension of Incentive Examination scheme to Senior Divisional Accounts Officers and Divisional Accounts Officers Grade-I.

Sir/Madam,

In accordance with Para 9.9 of the C&AG's MSO (Admn) Vol-I, Incentive Examination for Assistant Accounts Officer, Accounts Officer and Senior Accounts Officer of A&E offices is being conducted along with SAS Examination.

2. It has now been decided by the Competent Authority to extend the Incentive Examination scheme to Divisional Accounts Officers Grade-I (DAO Grade-I) who have put in one year continuous service in the grade and Senior Divisional Accounts Officers (Sr. DAO) from Incentive (Main) Examination 2017 as per the following guidelines:

- a) All Sr. DAOs are eligible to appear in the examination. However, DAOs Grade-I should have put in 1(one) year continuous service in the grade as on 1st of the month in which examination is held.
- b) The number of chances admissible to the Sr. DAOs and DAOs Grade-I to pass the Incentive Examination shall be six.
- c) The minimum aggregate marks required for passing the 4 (four) papers of Incentive Examination would be 50 % in each paper of the Examination.
- d) A candidate who scores 50 % marks and above in any paper of Incentive Examination would be treated as 'passed' as well as 'exempt' from future appearance in that paper.
- e) In order to check the scope of guess work, negative marking to the extent 0.25 marks (25 percent) shall be deducted for each wrong answer.
- f) Sr. DAOs and DAOs Grade-I who pass the Incentive Examination would be granted one advance increment in their respective scales with effect from first of the month in which the examination is held.
- g) The syllabus for the examination shall be in accordance with the syllabus prescribed for Incentive Examination for Assistant Accounts Officer, Accounts Officer and Senior Accounts Officer. The copy of the syllabus can be downloaded from the website of C&AG of India by using the link:

- h) All other criterion of the existing Incentive Examination for Assistant Accounts Officer, Accounts Officer and Senior Accounts Officer shall be applicable for DAOs Grade-I and Sr. DAOs also.
