Under no circumstances applications received beyond the said date will be entertained.

Vol-I "The candidates (including direct recruits) will not ordinarily be allowed more than three chances but Accountant General may in special circumstances, allow upto three additional chances to those whom he considers deserving of the concession".

Application of only those candidates who fulfil conditions laid down in chapter VII of the C & AG's M.S.O. extracts from which have been reproduced in the Appendix-I of the C.P.W.A. code, need be recommended.

A Certificate in the following form may be furnished for each candidate separately by the officer with whom the incumbent is working

"Certified that Sri / Smt. _____

_____ is regular in his/her attendance, energetic and is of good moral character and business like habits, that he possesses aptitude for working as D.A and that he has reasonable prospect of passing the Examination".

It may be noted that every candidate appearing in this examination must be a Sr.A/cs. Clerk appointed by this office on qualifying in the Initial Recruitment examination for Divisional Accountant. Candidates have to appear in all the following four subjects in the D.A.G. Exam, unless he has already been exempted from appearing in any of them.

Papers to be examined

- i) **Elementary Book keeping.**
- ii) **Public Accounts and Procedure (Theoretical)**
- iii) **Public Accounts and Procedure (Practical)**
- vi) **General Accounting Rules**

Unless otherwise communicated, the candidates should answer questions in the D.A.G.E. with reference to the new Head of Accounts. It may also be noted that the examination may be deferred if the transfer of cadre takes place before the commencement of examination.
