Sir/Madam,

Reference is invited to this office Circular No. 32/Staff (App1)-2012 issued vide letter No. 878-Staff (App 1)/25-2012 dated 06.09.2012 which states that to keep the SAS passed Gazetted Group 'B' officers abreast with the latest developments in the field of auditing on a continuous basis, and to test them on periodic basis on advanced topics in auditing, it has been decided to introduce a scheme of Continuous Professional Development (CPD) Tests.

2. Ministry of Finance, Department of Expenditure, New Delhi vide O.M. F. No. 12018/1/2013-EG dated 16.05.2019 has classified the post of Sr. Audit Officer and Sr. Accounts Officer in the Indian Audit and Accounts Department in pay Level-10 as Group 'A' without any change in the Pay Level (earlier classified as Group 'B' post).

3. In view of change in classification of posts of Sr. AOs from Group 'B' post to Group 'A' post, it is clarified that Sr. AOs (Group 'A' post) will continue to be eligible for the CPD tests as per the extant criteria.
