It has been observed that, a large number of Group 'B' (Gazetted & Non-Gazetted) and Group 'C' officials including M.T.S of this office have not yet furnished the same. A list of such officers/officials along with their name and designation is enclosed in Annexure-I. Therefore, all the officers/officials of this office who have not furnished their immovable property returns for the year 2022 so far, in terms of the office order referred above, are directed to submit the same in the Specified field in the official website by **09.06.2023** positively, **failing which appropriate administrative action may be initiated.**

All the Branch officers are requested to direct the officers and members of staff in the attached list, those who are under their control, to submit the immovable property returns for the year 2022, who have not yet submitted, positively by **09.06.2023**. Branch officers of Co-ordination Sections are also requested to submit an action taken report in the enclosed format (Annexure-II) from the Sectional in-charges in their respective wings along with a list of officials, positively by **13.06.2023**, who have not submitted the property return within the stipulated date for further administrative action at this end.

In case of any omission or discrepancies in the afore-mentioned list, the same may please be brought to the notice of Administration-I Section immediately.
