In terms of Headquarters circular bearing no. 04-Staff (Appt.)/PC Cell/02-2017 dated 09th July, 2018 read with Headquarters circular no. 1204-Staff (Appt.)/404-2018 dated 5.9.2018, the officers listed in Annexure have been granted Non-Functional Upgradation with effect from the dates noted against the name of each officer subject to the following conditions viz.:

- (i) The grant of Non-Functional Upgradation (NFU) in Pay Level 9 is admissible to the AAOs of IA&AD on completion of 4 years of regular service in the cadre from the date of joining as AAO.
- (ii) The benefit of pay fixation admissible as per Rule 13 of CCS (Revised Pay) Rules, 2016 shall be available at the time of grant of non-functional upgradation.
- (iii) The officers who have been granted non-functional upgradation shall exercise option, as per provision of FR 22(1)(a)(1) for pay fixation with effect from either the date of such upgradation or the date of their regular increment.
- (iv) NFU will be reckoned for financial upgradation under Modified Assured Career Progression Scheme (MACPS). Subsequent financial upgradation under MACPS, if any, is to be reckoned from the date of grant of NFU.

All officers are requested to exercise their option in the prescribed format obtainable from Administration-III section within one month from the date of issue of this order.
