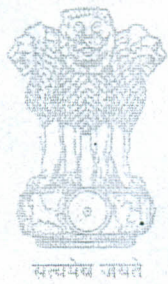

- The maximum age limit for appointment by deputation shall not exceed 56 years as on the closing date of receipt of application.
- The candidate once selected for the post will not be allowed to withdraw their candidature subsequently.
